Title: RESPIRATORY SYSTEM PROTECTION

Abstract: A respiratory system protection element is disclosed, in particular a breathing mask consisting of at least one layer (3, 4, 5) for protecting the nose and mouth. The core of the invention lies in that at least one means (6) is provided and/or integrated into the mask which by exposure to the breathing air allows the length of usage to be recognized.

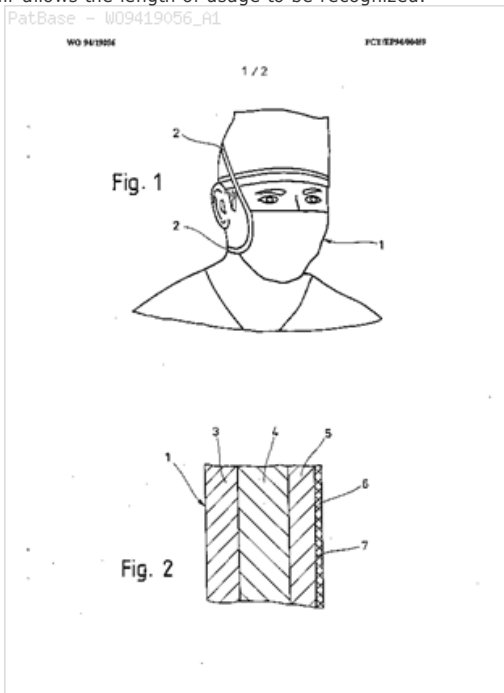

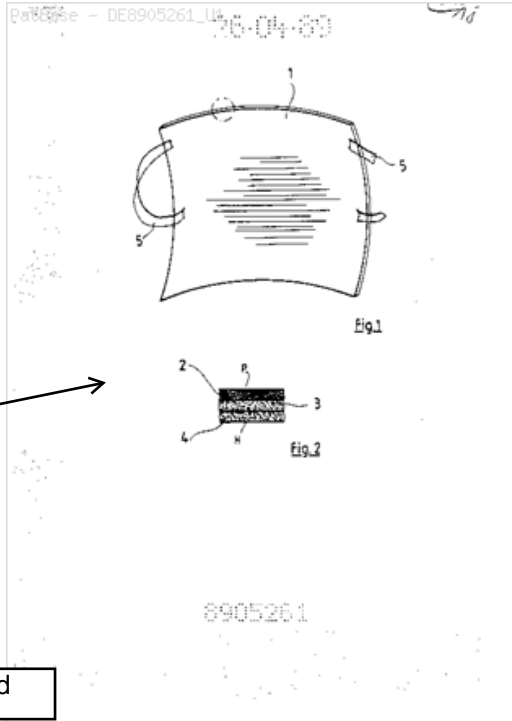

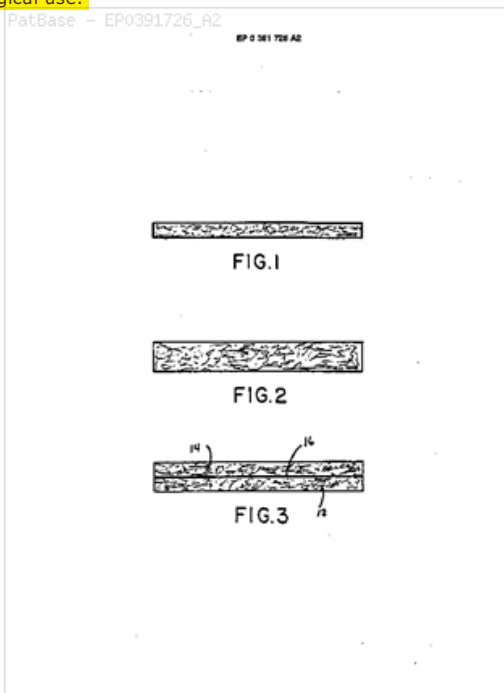

Title: IMPROVED FILTRATION MEDIUM AND FACE MASK CONTAINING THE SAME.

Abstract: Improved filtration medium comprises at least two individual, separate and distinct layers of melt blown fibers, the layers being arranged in face-to-face contact. The two-layered filtration medium has better particulate filtration efficiency (for particles 0.8 micron in diameter and larger) than that provided by a single layer of the same melt blown fibers having a basis weight equivalent to the combined basis weight of the two individual layers. The improved filtration medium is useful in the manufacture of **face masks, especially face masks for medical or surgical use.**

Title: SURGICAL MASK

Abstract: (Claim 1) 1. In a surgical mask comprising means attachable to the head for forming a shield and having a portion adapted to be disposed in alignment with the nose and mouth, said portion having at least one opening therein, and breathing means across said opening for allowing air expired from the nose and mouth to pass therethrough, the improvement comprising a honeycomb body, as 5 breathing means, across said opening and having a pair of opposed surfaces, one of said surfaces forming part of the rear surface of said mask for confronting relation to the nose and mouth and the other of said surfaces forming part of the front surface of said mask, a plurality of 10 unobstructed air channels extending through said body and terminally opening in said surfaces, said channels being defined and separated from one another by thin ceramic walls having porous, moisture absorbent surfaces, said body comprising a plurality of consecutive 15 sections between said surfaces with at least a portion of each of said channels extending through each section disposed at an oblique angle to said surfaces different from the oblique angular disposition of the channels in an adjacent section[^] 20

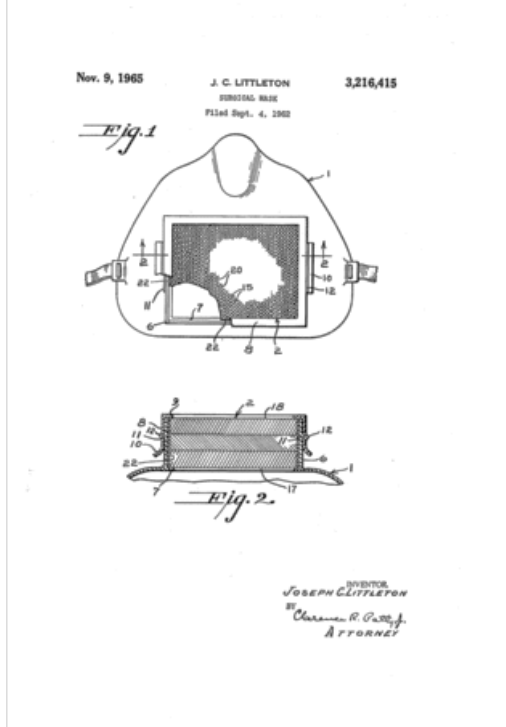
